Paying for your funeral plan

Golden Charter is required to invest all funeral plan payments into a trust fund run by an independent Board of Trustees or a life assurance policy regulated by the Financial Conduct Authority and the Prudential Regulation Authority (PRA). This means your money is managed independently from Golden Charter itself. In addition, the Funeral Planning Authority, of which Golden Charter is a member, exists to help protect plan holders' interests.

Golden Charter will receive funds for the provision of Will services from the Trust. Please refer to the terms and conditions for further information.

Single payment in full

- Payments in full will be paid into the Golden Charter Trust
- Will and 10 years of annual updates and storage included within your plan
- For an additional £100, you can guarantee that third party costs will be covered if you die within five years of the plan start date. Please see terms and conditions for details

- If you stop paying after 12 months, your plan remains in place. When you die, the funeral director will receive all the money you have paid in, less a £249 cancellation fee, as a contribution towards your funeral

Pay by fixed monthly payments

If you pay by fixed monthly payments, at the end of the first two years, and as long as you keep making your payments when due, your funeral director's services included within your plan will be guaranteed. Your funeral arrangements are made with Golden Charter, who will use your payments to take out a life assurance policy with AXA Wealth Ltd. This will fund your funeral when you die (for further information see the terms and conditions).

- You can pay by fixed monthly payments if you are a UK resident aged between 50 and 80
- Your fixed monthly payments depend on your age and which funeral plan you choose at the time of taking out your plan
- Payments need to be made every month until you are aged 90, or until you die – whichever is sooner
- Your monthly payments must be made by Direct Debit
- The services included within your funeral plan will only be covered after you've been paying into the plan for two years
- If you were to die within the first two years, the services included within your funeral plan would not be covered. However, your selected funeral director could still carry out the funeral. The funeral director would receive all of the money you have paid in plus an additional 20% to help towards the cost of your funeral (see terms and conditions)
- Depending on how long you live, the total cost of the funeral when you die may be less than the total payments made
- If you cancel your plan after 30 days you will not receive any money back. Please refer to the Key Features Document for more details
